



VISA REQUIREMENTS

Please complete the Visa Application Form in detail. Failure to do so may result in a subsequent delay and / or refusal of the visa. Also, submit your application together with the following requirements (where applicable).

- Passport valid for no less than 6 months and containing at least **three (3) blank pages** for endorsement;
- 2 recent taken passport size photographs (any colour background);
- Copy of passport;
- Copy of valid Malaysian Pass;
- Flight details (must be at least 3 days after visa application submission)
- Hotel booking confirmation; if you are staying at your friend's / relative's house, provide a personal letter with full address, contact number and copy of their passport / IC;
- 3 months bank statement (if applicable);
- Letter of invitation (business purpose);
- If you are working or studying in Malaysia, kindly provide confirmation letter of absent and when you are required to return from your Company / University;
- If you are self-employed, provide copy of your company registration certificate;
- If you are married to a Malaysia, provide copy of your marriage certificate and IC of spouse;
- If you are a PR of Malaysia, provide copy of your PR card;

For employment visa, please submit your completed medical report together with your passport and approval letter from the Immigration Office Department, Negara Brunei Darussalam.
